Covenant Woods Entrance Fee Options

Declining Refund Entrance Fee: A portion of the Entrance Fee paid is refunded to you or your estate if you leave Covenant Woods within 49 months after the Occupancy Date. The refund will be an amount equal to the Entrance Fee paid less 2% of the Entrance Fee paid for each full or partial month of residency until the balance is 0.

50% Refundable Entrance Fee: No less than 50% of the Entrance Fee paid is refunded to you or your estate if you leave Covenant Woods. The refund will be an amount equal to the Entrance Fee paid less 2% of the Entrance Fee paid for each full or partial month of residency, through the 25th month of residency, at which time the refund will be 50% of the Entrance Fee, regardless of the length of residency at Covenant Woods. Not available to persons above the age of 89.

90% Refundable Entrance Fee: No less than 90% of the Entrance Fee paid will be refunded to you or your estate if you leave Covenant Woods. The refund will be an amount equal to the Entrance Fee paid less 2% of the Entrance Fee paid for each full or partial month of residency through the 5th month of residency, at which time the refund will reach 90% of the Entrance Fee. It will remain a constant 90% thereafter, regardless of the length of residency at Covenant Woods. Not available to persons above the age of 89.

Modified Residency Agreement with Per Diem Healthcare Entrance Fee: A lower entrance fee which does not provide pre-payment toward future health care. A portion of the Entrance Fee paid is refunded to you or your estate if you leave Covenant Woods within 49 months after the Occupancy Date. The refund will be an amount equal to the Entrance Fee paid less 2% of the Entrance Fee paid for each full or partial month of residency until the balance is 0.

All monthly fees are associated with the residence type and do not change with entrance fee option selection. Services included:

- › *The Community's Flex Spending Plan*
- › *Weekly housekeeping*
- › *Real estate taxes and utilities: electricity, water, natural gas, sewer, and refuse*
- › *Cable TV hook-up and basic Comcast channels*
- › *Washer and dryer, stove, dishwasher, refrigerator, and microwave, and maintenance of appliances furnished*
- › *Maintenance of residence and grounds*
- › *Transportation in accordance with the community policies*
- › *Activities, fitness and wellness programs*
- › *Campus security*
- › *Emergency call system*
